Invitation to Bid for CY 2018 Basic Education Facilities Fund (BEFF) Electrification of Un-Energized Schools & Modernization of Electrical Systems of On-Grid Schools (Batch 3)

1. The Department of Education, Division of Davao del Norte, through the FY 2018 GAA intends to apply the sum of *Philippine Pesos Four Million Six Hundred Two Thousand Eight Hundred Sixty-Six and 00/100 Pesos (Php4,602,866.00)* being the Approved Budget for the Contract (ABC) to payments under the contract CY 2018 Basic Education Facilities Fund (BEFF) Electrification of Un-Energized and Modernization of Electrical Systems of On-Grid Schools (Batch 3). Bids received in excess of the ABC shall be automatically rejected at bid opening. The recipient schools are clustered as follows:

2. DepEd Davao del Norte now invites bids for the CY 2018 Basic Education Facilities Fund (BEFF) Electrification of Un-Energized and Modernization of Electrical Systems of On-Grid Schools (Batch 3). Completion of the Works is required *300 Calendar Days*. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."


Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from DepEd Division of Davao del Norte and inspect the Bidding Documents at the address given below from 8:00 am – 5:00 pm.
5. A complete set of Bidding Documents may be acquired by interested bidders on *[insert date of availability of Bidding Documents]* from the address below and upon payment of applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPBB in the amount of Five Thousand Pesos (Php 5,000.00).
6. The Division of Davao del Norte will hold a Pre-Bid Conference³ on *October 26, 2018, 1:30pm* at DepEd Division Davao del Norte Conference Hall, Brgay. Mankilam Tagum City Davao del Norte, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before *November 07, 2018, 1:30pm*. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on *November 07, 2018, 1:30pm* at DepEd Davao del Norte Division, Brgy. Mankilam Tagum City Davao del Norte. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The DepEd Division of Davao del Norte reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
