Bids shall be per cluster basis; bids received in excess of the ABC per cluster shall be automatically rejected during bid opening.

- 2. The *Department of Education-Division of Davao del Norte* now invites bids for the above Procurement Project. Completion of the Works is required *in Eighty Calendar Days (80 CD)*. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
- 4. Interested bidders may obtain further information from *Department of Education-Division* of *Davao del Norte* and inspect the Bidding Documents at the address given below from 8:00 AM to 5:00 PM.
- 5. A complete set of Bidding Documents may be acquired by interested bidders on *August 23* September 15, 2021 at 8:00 AM to 5:00 PM from given address below and *upon payment*of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued
 by the GPPB, in the amount of Twenty Five Thousand Pesos (P 25, 000.00) for cluster
 DDN-E2020-003 and Ten Thousand Pesos (P 10,000.00) for cluster DDN-E2020-004. The
 Procuring Entity shall allow the bidder to present its proof of payment for the fees.
- 6. The *Department of Education-Division of Davao del Norte* will hold a Pre-Bid Conference¹ on August 31, 2021 at **10:00 AM** at *Division Office Conference Hall, Mankilam, Tagum, City*, which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat at the office address as indicated below. Late bids shall not be accepted.
- 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.
- 9. Bid opening shall be on *September 15*, 2021 at 9:00 AM at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 10. The *Department of Education-Division of Davao del Norte* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing
