**Invitation to Bid for *CY 2020 BASIC EDUCATIONAL FACILITIES FUND (BEFF) ELECTRIFICATION OF UN – ENERGIZED SCHOOLS AND MODERNIZATION OF ELECTRICAL SYSTEM OF ON-GRID SCHOOLS BATCH 3 AND 4***

1. The *Department of Education-Division of Davao del Norte*, through the *FY 2020 Government Appropriations Act (GAA)* intends to apply the sum of Twenty Two Million Two Hundred Seventy Thousand Nine Hundred Seven Pesos (*P22,270,907.00*) being the Approved Budget for the Contract (ABC) to payments under the contract for *CY 2020 Basic Educational Facilities Fund Electrification of Un-energized Schools and Modernization of Electrical Systems of On-grid Schools*:

Bids shall be per cluster basis; bids received in excess of the ABC per cluster shall be automatically rejected during bid opening.

2. The *Department of Education-Division of Davao del Norte* now invites bids for the above Procurement Project. Completion of the Works is required *in Eighty Calendar Days (80 CD)*. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from *Department of Education-Division of Davao del Norte* and inspect the Bidding Documents at the address given below from *8:00 AM to 5:00 PM*.
5. A complete set of Bidding Documents may be acquired by interested bidders on *August 23 – September 15, 2021* at 8:00 AM to 5:00 PM from given address below and *upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Twenty Five Thousand Pesos (P 25, 000.00) for cluster DDN-E2020-003 and Ten Thousand Pesos (P 10,000.00) for cluster DDN-E2020-004*. The Procuring Entity shall allow the bidder to present its proof of payment for the fees.
6. The *Department of Education-Division of Davao del Norte* will hold a Pre-Bid Conference<sup>1</sup> on August 31, 2021 at **10:00 AM** at *Division Office Conference Hall, Mankilam, Tagum, City*, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the office address as indicated below. Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.
9. Bid opening shall be on *September 15, 2021 at 9:00 AM* at the given address below. Bids will be opened in the presence of the bidders’ representatives who choose to attend the activity.
10. The *Department of Education-Division of Davao del Norte* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing


