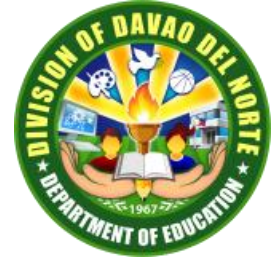

INVITATION TO BID FOR THE VARIOUS MEDICAL SUPPLIES AND MATERIALS FOR THE IMPLEMENTATION OF MINIMUM HEALTH STANDARD PROTOCOLS

1. The Department of Education Division of Davao del Norte, through the **CY 2020 General Appropriations Act** intends to apply the sum **Philippine Pesos One Million Three Hundred Ninety-Six Thousand Six Hundred Twenty-Nine and 00/100 Pesos (PhP1,396,629.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Various Medical Supplies and Materials for the Implementation of Minimum Health Standard Protocols**, detailed as follows:

Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. DepEd, through its Bids and Awards now invites bids for the above – mentioned goods and ancillary services. Delivery of the Goods is required within **15 days**. Bidders should have completed, within **three years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.
 - (i) Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
4. Interested bidders may obtain further information from www.depeddavnor.ph or www.philgeps.gov.ph and inspect the Bidding Documents at the address given below during office hours.
5. A complete set of Bidding Documents may be acquired by interested Bidders from the address below *upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Philippine Pesos Five Thousand Pesos and 00/100 (PhP5,000.00)***. Only bidders that purchased the Bidding Documents will be allowed to submit bids.

Bid opening shall be December 14, 2020 @ 3:00 pm. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

DepEd Davao del Norte Division reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
