Early procurement activities for the other procurement projects in FY 2021 were not conducted because the Schools Division of Davao del Norte did not receive any Authority to Procure or any Special Allotment Release Order or any authority to conduct Early Procurement Activities from the DepED – Central Office.

Section 3.4.3 of the Government Procurement Policy Board (GPPB) Circular 06-2019 on the Guidelines on the Implementation of Early Procurement Activities (EPA) specifically provides:

"3.4.3. For Procurement Projects funded by forthcoming sub-allotments from the Central Office (CO) or Centrally-Managed Items, the written approval, in whatever form, from the CO identifying the implementing unit therefor with the corresponding amount and authorizing the conduct of EPA shall be the basis for the conduct of said activity."

Without said authority from the DepED – Central Office, the Schools Division of Davao del Norte cannot proceed with the conduct of EPA since the procurement projects of the Division are all funded by allotments from the CO.
