Invitation to Bid for CY 2020 Basic Educational Facilities Fund Repair of Classrooms

1. The Department of Education, Division of Davao del Norte, through the FY 2020 GAA intends to apply the sum of *Philippine Pesos Twelve Million Seven Hundred Thirty-One Thousand Four Hundred Forty-One and 3/100 Pesos (Php12,731,441.03)* being the Approved Budget for the Contract (ABC) to payments under the contract CY 2020 Basic Educational Facilities Fund Repair of Classrooms. Bids received in excess of the ABC shall be automatically rejected at bid opening. The recipient schools are clustered as follows:

- 2. DepEd Davao del Norte now invites bids for the CY 2020 Basic Educational Facilities Fund Repair of Classrooms. Completion of the Works is required 210 Calendar Days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least sixty (60%) interest or outstanding capital stock belonging to citizens of the Philippines.



 - Bid opening shall be on *December 16*, 2019, 3:00pm at DepEd Davao del Norte Division, Brgy. Mankilam Tagum City Davao del Norte. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The DepEd Division of Davao del Norte reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
