## INVITATION TO BID FOR THE CY 2023 LAST MILE SCHOOLS PROGRAM BATCH 2

1. The Department of Education-Division of Davao del Norte, through the FY 2023 Government Appropriations Act (GAA) intends to apply the sum of Thirty Six Million Three Sixty One Thousand Three Hundred Fifty Nine and 20/100 Pesos (P36,361,359.20) being the Approved Budget for the Contract (ABC) to payments under the contract for CY 2023 Last Mile Schools Program Batch 2 clustered as follows:

Bids received in excess of the ABC per cluster shall be automatically rejected during bid opening.

- 2. The Department of Education-Division of Davao del Norte now invites bids for the above Procurement Project. Completion of the Works is required in Three Hundred Sixty Calendar Days (360 CD). Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

- 4. Interested bidders may obtain further information from Department of Education-Division of Davao del Norte and inspect the Bidding Documents at the address given below from 8:00 AM to 5:00 PM.
- 5. A complete set of Bidding Documents may be acquired by interested bidders on October 17 November 6, 2023 at 8:00 AM to 5:00 PM from given address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Twenty Five Thousand Pesos (P 25, 000.00). The Procuring Entity shall allow the bidder to present its proof of payment for the fees.
- 6. The Department of Education-Division of Davao del Norte will hold a Pre-Bid Conference<sup>1</sup> on October 24, 2023 at 1:30 PM at Division Office Conference Hall, Mankilam, Tagum, City, which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat at the office address as indicated below. Late bids shall not be accepted.
- 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 16.
- 9. Bid opening shall be on *November 6, 2023 at 1:00 PM* at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 10. The Department of Education-Division of Davao del Norte reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
