INVITATION TO BID

FOR THE PROCUREMENT OF NUTRITIOUS FOOD PRODUCTS FOR THE IMPLEMENTATION OF SCHOOL BASED FEEDING PROGRAM (SBFP) - FY 2023

1. The **Department of Education Division of Davao del Norte**, through the **CY 2024 General Appropriations Act** intends to apply the sum of **One Million Eight Hundred Fifty-Five Thousand Six Hundred Fifty-Six Pesos (P 1,855,656.00)** being the ABC to payments under the contract for the **Procurement of Nutritious Food Products for the Implementation of SBFP-FY 2023**. Bids received in excess of the ABC shall be automatically rejected at bid opening. Details were as follows:

2. The **Department of Education Division of Davao del Norte** now invites bids for the above Procurement Project. Delivery of the Goods is required by **150 calendar days/5 months (monthly delivery)**. Bidders should have completed, within **three (3) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
4. Prospective Bidders may obtain further information from the **Department of Education Division of Davao del Norte** and inspect the Bidding Documents at the address given below from **8:00AM-5:00 PM**.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **November 21, 2024-December 11, 2024** from the given address and website(s) below and upon submission of letter of intent and payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Thousand Pesos (P 5,000.00) for Lot 1 or both Lot 1 & 2 and Five Hundred Pesos for Lot 2 only** . The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person.
6. The **Department of Education Division of Davao del Norte** will hold a Pre-Bid Conference¹ on **November 29 (Friday) @ 10:00 AM** at the Division Office Conference Room which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below, on or before **December 11, 2024 (Wednesday) @ 10:00 AM**. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 14**.
9. Bid opening shall be on **December 11, 2024 (Wednesday) @ 10:00 AM** at the given address below. Bids will be opened in the presence of the bidders’ representatives who choose to attend the activity.

The **Department of Education Division of Davao del Norte** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
