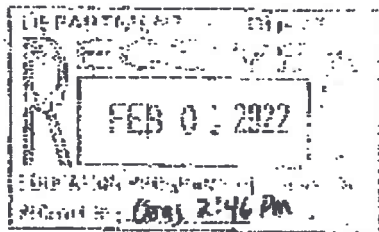

# HOW TO AVOID ONLINE FRAUD




**CHECK THE URL**  
To protect communication on public networks, make sure that the address you are accessing is secure and that




**IMAGE CHECK**  
Be cautious of images you receive via social media or email.




**STAY CALM NO SHARING**  
Never share your password with anyone.




**USE YOUR OWN DEVICE**  
Avoid using public Wi-Fi for logging on to sensitive information.




**PROPER VERIFICATION**  
Activate the security alerts on your mobile phone and email. Verify the sender's name and email address for any online bank transfer.



**CHECK EMAIL ADDRESS**  
Check if the name you received alerts or payments transfers from the legitimate and authorized bank email.



**AVOID DIRECT BANKING**  
Use the bank's official website or mobile and phone banking applications.
