Subject: ENHANCED REFRESHER COURSE FOR COACHES

Date: January 03, 2025

- Pursuant to Section 6,7,8, and 10 of Rule II of the Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 10588 otherwise known as the Palarong Pambansa Act of 2013, the Division of Davao del Norte shall conduct Enhanced Refresher Course for All Coaches on January 10-12, 2025 at Sto. Tomas National High School.
- 2. The competencies covered during the affected days of the training can be taught to the learners in advance to ensure they stay on track with their lessons. Similarly, teachers should prepare the learning activity materials ahead of time so these can be used by the substitute teachers handling the classes of those participating in the training. All of this should be done under the supervision of the school principal.
- 3. A registration of P150.00 for each participant to defray expenses such as: food and snacks for the facilitators, supplies and materials, minimal honorarium for plenary resource speakers, and electricity chargeable against PTA/ personal funds.
- 4. Service credits/ compensatory overtime credits (COC) shall be granted to the participants pursuant to DepEd Order No. 53, s. 2003.
- Travel and other incidental expenses of Division Personnel relative to the activity are chargeable against division MOOE while school heads and teachers are chargeable against school MOOE subject to the usual accounting and auditing rules and regulations.
- 6. A list of resource speakers and a matrix of activities are found in the enclosures.
- 7. Furthermore, the Equal Opportunities Principle (EOP) shall always be observed in participating in this activity, where all individuals are fully recognized regardless of gender, religion, ethnicity, and political affiliation.
