CONDUCT OF LANGILAN DISTRICT SCHOOLS PRESS CONFERENCE

Date: January 7, 2025

- Pursuant to Republic Act (RA) No. 7079, also known as the Campus Journalism Act of 1991, released through DepEd Order No. 91, s. 1992, which stipulates the holding of annual elementary, secondary, or tertiary Schools Press Conference, this Office informs the field of the conduct of "Langilan District Schools Press Conference" on January 16-18, 2025 at Gupitan Integrated School, Gupitan, Kapalong, Davao del Norte.
- 2. The conference aims to:
 - a) demonstrate an understanding of the importance of journalism through skillful execution in various platforms (i.e. print, broadcast, online);
 - b) recognize the role of journalism in advocating social consciousness and environmental awareness, and in building resilient communities;
 - c) promote fair and ethical use of media as tenets of responsible journalism;
 - d) foster camaraderie and enrich learning experiences through healthy and friendly competitions; and
 - e) allow learners to use the skills learned in campus journalism for their future careers.
- Furthermore, teacher-coaches accompanying student-writers shall secure parental consent. All School Heads and Administrative Officers (AOs) in Langilan District are encouraged to institutionalize this activity.
- 4. The teaching and non-teaching participants who shall render their time and services in the said event shall be given one-day service credit and compensatory overtime credit (COC) as stipulated in DO No. 53, s. 2023, and CSC and DBM Joint Circular No. 2. s. 2004 respectively.
- 5. Travel, meals, and other incidental expenses of the onsite participants shall be charged against local funds, all subject to the usual accounting and auditing rules and regulations.
- 6. Furthermore, the Equal Opportunities Principle (EOP) shall always be observed in participating in this activity, where all individuals are fully recognized regardless of gender, religion, ethnicity, and political affiliation.
- 7. Immediate dissemination of this memorandum is desired.
