- 1. In line with the commitment to ensure preparedness of ALS learners for the forthcoming Alternative Learning System Accreditation and Equivalency (ALS A&E) Test, the Division of Davao del Norte will conduct a Division Wide Practice Test on January 18, 2025. The activity will be simultaneously held across the 11 districts within the division.
- 2. The practice test aims to:
 - provide ALS learners with an experience similar to the actual ALS A&E Test
 - identify areas of strengths and weaknesses among ALS learners
 - formulate interventions to improve the overall performance in the ALS A&E Test
- 3. A post-test evaluation will be conducted to assess the results of the practice test. The findings will be used to create targeted interventions for ALS learners in preparation for the actual National ALS A&E Test scheduled on February 2, 2025.
