SYSTEM ACCREDITATION AND EQUIVALENCY (ALS A & E) Test

January 22, 2025

Pursuant to DepEd Order No. 063, s. 2024, on the 2024 Accreditation and Equivalency Test
Registration and Administration Guidelines, and in line with the commitment to provide access
to quality education for all, the Schools Division of Davao del Norte will administer the
Alternative Learning System Accreditation and Equivalency (ALS A&E) Test on February 2,
2024.

Relative to DepEd Order No. 55, s. 2016, the ALS A&E Test aims to measure the competencies and life skills of individuals who have not attended or completed formal Elementary or Secondary Education. This assessment allows learners to obtain certification of completion at various exit points in Basic Education, which may be used to access further education, job promotion, job training, and employment.

- The target participants for this examination are all ALS learners who have completed the learning modules and are recommended by their Learning Facilitators.
- 3. The ALS A&E Test will be conducted at the following testing centers:
  - Carmen National High School
  - Davao Prison and Penal Farm
  - Davao Provincial Rehabilitation Center
- 4. All District Supervisors, School Heads, and ALS Coordinators are hereby directed to:
  - Ensure the wide dissemination of this information to all concerned individuals and institutions.
  - Provide the necessary support and assistance to facilitate the smooth conduct of the ALS A&E Test.
  - Coordinate with ALS Implementers in their respective areas for the preparation and administration of the test, including the billeting quarters at Carmen Central Elementary School.

- 5. An Orientation for all Testing Personnel for the ALS A&E Test will be held February 1, 2025. This session aims to ensure that examiners are thoroughly briefed on their roles, responsibilities and the procedures to be followed during test administration.
- A Regional Monitoring and Evaluation of the preparation and readiness of the 38 testing centers across the 11 Schools Division Offices (SDOs) will be conducted on January 15-16, 2025. This will be followed by an ocular visit of the testing centers by Central Office (CO), Regional Office (RO), and Division Office (DO) Monitors on February 1, 2025.
- 6. DepEd teaching personnel who will participate and serve during the conduct of the Division-Wide Alternative Learning System Accreditation and Equivalency (ALS A&E) Practice Test shall be granted Service Credits or Compensatory Overtime Credit (COC) pursuant to the provisions of DepEd Order No. 53, s. 2023.
- Meals, transportation allowances, and honoraria of the participants are chargeable against
  the Program Support Funds for the preparation and administration of the Alternative
  Learning System Accreditation and Equivalency (ALS A&E) Test, subject to existing
  accounting and auditing regulations.
- All stakeholders are encouraged to continuously support and value equality and diversity in all activities related to this endeavor.

- 9. Immediate dissemination of this Memorandum to all concerned is desired.
