- 1. In view of the participation of Asuncion District Athletic Association to the conduct of Division Meet 2025 on February 13-16, 2025, at DNSTC, this Office informs the field that all qualified athletes and coaches of Asuncion District are hereby instructed to hold training/practice starting February 3, 2025, at 3 o'clock in the afternoon during weekdays and whole day on weekends dated February 8 and 9, 2025. PSDS and School Heads assigned to each event should monitor the activity, assess the performance, and provide necessary assistance to improve the skills of each participant.
- 2. The teaching personnel involved in this activity are entitled to service credits for services rendered during weekends as stipulated in DepEd Order No. 53, s. 2003. On the other hand, non-teaching personnel shall be provided with Compensatory Overtime Credit (COC) as per Civil Service Commission (CSC) and Department of Budget and Management (DBM) Joint Circular No. 2 s. 2004.
- 3. Transportation and all other allowed expenses to be incurred during the conduct of this activity shall be chargeable against School Maintenance and Other Operating Expenses (MOOE) and any other local funds subject to the usual accounting and auditing rules and regulations.
- 4. All participants of the Division Meet 2025 shall report at the delegation billeting quarter at Cambanogoy Central Elementary School on February 11, 2025, at 1 o'clock in the afternoon. All classes of Camabanogoy CES shall shift into blended learning from February 11, 2025, up to February 14, 2025.
- 5. Everyone is highly encouraged to continually support and recognize the value of equality and diversity of all personnel while complying with the directives set forth by this office.
