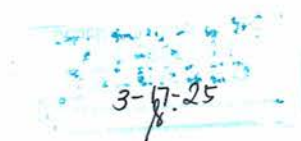

This initiative aims to strengthen the reading skills of learners, identify struggling readers, and provide suited interventions to address literacy gaps.
