Subject: **CONDUCT OF DIVISION MONITORING ON THE READINESS OF ALTERNATIVE LEARNING SYSTEM ACCREDITATION AND EQUIVALENCY (ALS A & E) TEST**

Date: January 7, 2026

1. In preparation for the conduct of the Alternative Learning System Accreditation and Equivalency (ALS A&E) Test, this Division shall undertake a monitoring activity to assess the readiness of ALS implementing units. This initiative ensures that all requirements, standards, and support mechanisms are in place to facilitate the smooth and orderly administration of the ALS A&E Test.
2. The monitoring aims to:
  - assess the preparedness of ALS implementers for the ALS A&E Test;
  - determine compliance with prescribed ALS A&E policies and guidelines;
  - ensure readiness of learners, facilitators, learning centers, and test-related documents.
3. Scope of monitoring:
  - Learner enrolment and eligibility documents
  - Readiness of ALS implementers and learning facilitators
  - Availability of learning resources and facilities
  - Compliance with ALS A&E Test requirements and standards
  - A & E Practice Test on the first week of February, 2026
4. The monitoring shall be conducted on **January 14, 15, 20, 21, 22, 27, 28, 2026** in eleven (11) districts within the Schools Division of Davao del Norte. The specific schedule and district coverage shall be coordinated through the CID Chief.
5. The monitoring team shall be composed of personnel from the **Curriculum Implementation Division (CID)**, Education Program Supervisor and Education Program Specialist II in ALS.
6. All are encouraged to continuously support and value equality and diversity in all activities related to their endeavor.
7. Immediate dissemination of this memorandum is desired.
