Subject: **CONDUCT OF ACCREDITATION AND EQUIVALENCY (A&E) PRACTICE TEST**

Date: February 2, 2026

1. In preparation for the upcoming Accreditation and Equivalency (A&E) Test, this Office announces the conduct of the A&E Practice Test across the Schools Division of Davao del Norte on February 3-8, 2026.
2. The activity aims to:
  - a. assess learners' readiness for the A&E Test;
  - b. familiarize learners with the test format and procedures;
  - c. identify learning gaps for targeted intervention; and
  - d. strengthen monitoring and support mechanisms for ALS implementers.
3. Please refer to the attached Enclosure for the schedule of the conduct of the A&E Practice Test, including venues and assigned monitoring personnel.
4. The assigned Monitoring Personnel are directed to:
  - a. ensure proper administration of the practice test following standard testing protocols;
  - b. provide technical assistance to ALS teachers and Community ALS Implementers (CAIs);
  - c. validate attendance and completeness of practice testing materials; and
  - d. document observations, issues, and best practices during the conduct of the activity.
5. Public Schools District Supervisors and ALS Focal Person shall ensure the attendance of all A&E Test Registrants and provide necessary logistical support for the smooth implementation of the activity.
6. Transportation and other authorized expenses relative to the conduct of the activity shall be charged against available ALS Program Support Funds (PSF) and/or LGU PSF, subject to existing accounting and auditing rules and regulations.
7. Personnel who are assigned to render service on February 7, 2026 (Saturday) and February 8, 2026 (Sunday), shall be entitled to Compensatory Overtime Credit (COC) in accordance with Civil Service Commission (CSC) Memorandum Circular No. 06, s. 2005 (Guidelines on the Grant of Compensatory Time-Off) and relevant Department of Education issuances on the grant of COC. The grant and utilization of COC shall be subject to submission of duly approved authority to render overtime service and certification of actual service rendered, following existing accounting, auditing, and administrative rules and regulations.
