1. In support to the hosting of DAVRAA 2026, this Office informs the Division schools of the exhibit of the Senior High School Program's outputs, and products through an Open Market or "Tiangge" on **February 22-28, 2026** at the Davao del Norte Sports and Tourism Complex. The following information are presented to guide the Senior High School community, to wit:
 - a) The installation of booth shall be on **February 17-19, 2026** to give time for the installation of electricity and water system;
 - b) Each exhibitor/ school must provide its own booth, free from any political attachment;
 - c) The clustering of the exhibition is led by the Congressional District's Team Leaders:

Mr. Alan Jr Paglinawan-- Principal II


Congressional District II - Dr. Aser M. Samsona- Principal IV

 - d) A simple Opening Ceremony shall be conducted on **February 22, 2026** at the designated area of the Open Market "Tiangge" (*near the DAVNOR Multipurpose Coliseum*).
2. The school heads are also advised to adhere to the policies, scheme and other agreements as discussed during the Senior High School Meeting, dated February 6, 2026.
3. Moreover, the teacher participants shall be entitled to service credits in accordance with DepEd Order 53, s. 2003 entitled: Updated Guidelines on the Grant of Vacation Service Credits to Teachers, for services rendered during Saturday. On the other hand, non-teaching personnel shall be provided with Compensatory Time-off (CTO) as per Civil Service Commission (CSC), and Department of Budget and Management (DBM) Joint Circular No. 2, s. 2004 on Non-Monetary Remuneration for Overtime Service Rendered for the services rendered during Saturday, Sunday and Holidays.

4. Travel, meal and other incidental expenses relative to this activity are chargeable against the Division/ School MOOE, subject to the usual accounting, and auditing rules and regulations.
5. Everyone is highly encouraged to continually support and recognize the value of equality and diversity of all personnel while complying with the directives set forth by this office.
