1. This Addendum is issued to inform all concerned that participants in the Division Training on the Alignment of Classroom and National Assessments shall be granted with **three (3) days Service Credits** for teaching personnel and **Compensatory Overtime Credit (COC)** for non-teaching personnel and for their participation on **February 14, 2026 (Saturday), February 15, 2026 (Sunday), and February 17, 2026 (Tuesday – Special Non-Working Holiday)**, covering the period of the conduct of the activity, subject to existing Civil Service Commission (CSC) and Department of Education policies, rules, and regulations.

*Granting of **Service Credits** for teaching personnel shall be in accordance with **DepEd Order No. 53, s. 2003 (Updated Guidelines on Grant of Vacation Service Credits to Teachers)**, while the granting of **Compensatory Overtime Credit (COC)** for non-teaching personnel shall be subject to **CSC-DBM Joint Circular No. 2, s. 2004**, and other applicable Civil Service Commission and Department of Education policies, rules, and regulations. The grant shall be subject to the submission and verification of complete attendance and participation documents duly approved by the proper authority.*

2. This training has an approved Continuing Professional Development (CPD) accreditation equivalent to **13.50 CPD units** from the Professional Regulation Commission (PRC).


