2. Ms. Maregine T. Atabelo, RN, is hereby designated to serve as Medical Welfare Officer for the entire duration of the activity.
3. All stipulated provisions in the Division Memorandum CID-2026-0170 which are not affected by this Addendum remain valid and in full force and effect.


