

1. The school head shall arrange the class schedule of the involved teacher(s) and ensure that classes are handled by a qualified substitute teacher. Learners shall likewise be provided with appropriate academic support through Alternative Delivery Mode (ADM) to compensate for missed classes.
5. The travel, accommodation, food, and other related expenses of the Coach and Learners shall be fully shouldered by Nestlé Philippines, Inc., through Greatfil Team, Inc. However, should there be DepEd key officials who wish to witness and extend full support to the participants during the competition, expenses incurred relative to the activity, including travel, accommodation, and food, shall be charged on personal accounts.
