This activity aims to orient the School Heads, School Presidents, and SHS Coordinators to provide general and important information on the implementation of the new SHS curriculum program.


We have ensured that all necessary preparations and safeguards are in place to comply with DepEd policies and to ensure the safety and well-being of all participants.
