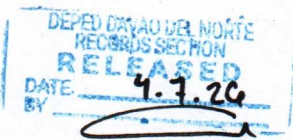

- In line with the Department of Education's commitment to promote awareness and proper implementation of national laws safeguarding the welfare of learners and personnel, this Office grants permission to PSDS Dominic M. Dizon, all School Heads and selected Administrative Officers of Langilan District to participate in the One-Day Orientation Seminar on Republic Act No. 11596 (*An Act Prohibiting Child Marriage*) and Republic Act No. 11313 (*Safe Spaces Act*) on April 07, 2026, from 8:00 AM to 5:00 PM at MSWDO Conference Room, Maniki, Kapalong, Davao del Norte.
- This activity aims to strengthen the awareness and understanding of school personnel assigned in Indigenous Peoples (IP) communities in Kapalong regarding the provisions of these laws, particularly in preventing child marriage, gender-based harassment, and other forms of abuse against children and learners.
- The orientation will also emphasize the important role of schools in the early identification, reporting, and protection of children who may be at risk of child marriage and gender-based violence.
- Travel, meals, and other incidental expenses of the onsite participants shall be charged against LGU funds, all subject to the usual accounting and auditing rules and regulations.
- Furthermore, the Equal Opportunities Principle (EOP) shall always be observed in participating in the activity, where all individuals are fully recognized regardless of gender, religion, ethnicity, and political affiliation.
