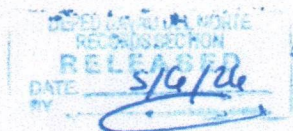
3. Further, the host school is reminded that no lavish preparation shall be made for the activity, and all arrangements must ensure no disruption regular school operations.
