**RENAMING OF CABAYWA UPPER ELEMENTARY SCHOOL OF THE  
SCHOOLS DIVISION OFFICE OF DAVAO DEL NORTE TO  
GAVINO E. AMOGUIS ELEMENTARY SCHOOL**

1. This Regional Office hereby announces the renaming of **CABAYWA UPPER ELEMENTARY SCHOOL** to **GAVINO E. AMOGUIS ELEMENTARY SCHOOL** effective **School Year 2022-2023 and the school years thereafter**.
2. The National Historical Commission of the Philippines approved on February 23, 2022 Sangguniang Bayan Resolution No. 2020-218, dated September 15, 2020 of the Local Government Unit (LGU) of Asuncion, Davao Del Norte renaming Cabaywa Upper Elementary School to Gavino E. Amoguis Elementary School. The LGU resolution supported Resolution No. 2019-021 of the Barangay Council of Cabaywa, Municipality of Asuncion, Province of Davao Del Norte, requesting the renaming of Cabaywa Upper Elementary School to Gavino E. Amoguis Elementary School.
3. Section 99 (d) of Republic Act No. 7160 (Local Government Code of 1991) authorizes the Local Sanggunian to change the name of schools through an ordinance with the Local School Board as the recommending body. In addition, all public schools may be named or renamed by the President through a proclamation or by Congress through legislation.
4. To avoid any confusion in mail matters and the management of records, the concerned school and Schools Division Office is directed to ensure that the former name of the school be placed underneath its new name together with the name of the barangay. The new signage should appear as follows:
