

3. Immediate dissemination of this Memorandum to all concerned is desired.

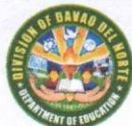
