As one DepEd Family and the neighbor Region of the DepEd CARAGA, this Office mobilizes all Division Offices including the Regional Office through the Regional and Division Engineers and DRRM Coordinators to have ocular inspection and visit of damaged schools hit by Typhoon Odette last December, 2021 in CARAGA Region on January 11-13, 2022.

It is advised that the team (Engineer and DRRM Coordinator) from each Division shall lead in the identification of one school to be adopted by the Division through the concept of "Brigadahan sa Eskwelahan Para sa Magandang Kinabukasan". The advance party will identify and asses the needs of the adopted school such as manpower, construction materials, school and office supplies and among others.

Further, the Regional and Division teams will coordinate with the DepEd CARAGA Regional Office regarding this matter and are expected to have a comprehensive report what to be done after the visit and ocular inspection. In additional, it is advised that the pick-up vehicle issued by the Central Office shall be used during the said visit.

Travelling and other incidental expenses shall be charged against local funds subject to the usual auditing and accounting rules and procedures.
