Eligibility Mechanics:

- 1. Must be a teaching and non-teaching personnel of Davao del Norte division.
- 2. Must be between 25 to 45 years old.
- 3. Must possess excellent communication skills in English.
- 4. Must have prior experience in hosting events.

Criteria for Judging 2025 DAVRAA Meet Hosts:

- 1. Presentation Skills (30%)
 - Clarity and coherence in speech
 - Confidence and stage presence
 - Appropriate use of language and tone
- 2. Content (25%)
 - Relevance and depth of content in answers and presentations
 - Originality and creativity
 - Ability to engage and connect with the audience
- 3. Personality (20%)
 - Charm and charisma
 - Professionalism and demeanor
 - Ability to handle unexpected situations gracefully
- 4. Appearance (15%)
 - Appropriate and professional attire
 - Overall grooming and presentation
- 5. Audience Impact (10%)
