- 1. Due to flood and weather conditions last time, this office declares February 29 to March 04, 2024, as the new schedule for the conduct of the 2024 Division Schools Press Conference at New Corella Central Elementary School-SPEd Center and New Corella National High School, New Corella District, Davao del Norte.
- 2. The decision to postpone again the 2024 DSPC last February 04 to 08, 2024 (which was originally set last February 02-06, 2024) was urgently made to ensure the utmost safety of the learners, teachers, and all participants of the event.
- 3. Moreover, the deadline for the School Paper shall also be on February 21, 2024 to give way for the evaluators to judge the papers and for the qualifying schools to have revisions before the deadline set at the Regional Level on March 04, 2024. Hard copies with Certificate of Circulation (in two copies) shall be submitted to the Curriculum Implementation Division (CID) Office, and the Soft Copies in PDF shall be submitted via Google Drive (link shall be forwarded).
- 4. Education Program Supervisors shall conduct an ocular inspection of the venues, performances, and other preparations for the activity on February 28, 2024. Travel and meal allowances shall be chargeable against Division MOOE and other local funds subject to usual auditing and accounting rules.
- 5. The rest of the items relative to the Division Memorandum No. 0036, s. 2024 on the conduct of 2024 DSPC and other related memoranda is retained.
- 6. Immediate dissemination of this Memorandum to all concerned is desired.
