3. Top two winning Collaborative Publishing and TV Broadcasting groups, and top five winning campus journalists in Newswriting, Feature Writing, Sports Writing, and Photojournalism shall serve in different schedules or dates within the entire duration of the activity. Campus journalists shall secure their parent's consent and authority to travel for their attendance in the activity.
4. Moreover, relative to the issuance of the Regional Memorandum CLMD-2025-123, titled, *"Participation of Media and Documentation Team of the Host Division in the 2025 Davao Region Athletic Association (DAVRAA) Meet"*, dated February 26, 2025, this Office also informs that identified DepEd Personnel, Campus Journalists, and Coaches enclosed in Division Memorandum No. 0048, s. 2025 will be the official team recognized by DepEd XI Regional Office responsible for the media and documentation coverage of the said activity.
5. To emphasize, campus journalists (both in individual and group events) as members of the media coverage and documentation bring honor to the school, district, and Division. Hence, they shall be credited with points in their academic subjects. Highest Possible Scores in written works, summative tests, and performance tasks in all subjects, so long graded, except for quarterly examinations shall be credited to CJs. Submission of Major projects/requirements (ex. research/portfolio for immersion) shall be given an extension.
6. Classes of the teacher-participants who shall accompany their campus journalists shall be arranged accordingly to avoid disruption of classes, adhering to the policy of *"No disruption of classes, pursuant to the provision under DepEd Order (DO) 9 s. 2005, Instituting Measures to Increase/ Engaged Time on Task and Ensuring Compliance Therewith"*.
7. Service Credits shall be granted to the teacher participant (DepEd Order No. 53, s. 2003) while Compensatory Overtime Credits (COC) shall be granted to other non-teaching personnel (CSC and DBM Joint Circular No. 2, s 2004) for services rendered during weekends, and holidays.
8. Meals, travel expenses, and other incidental fees of the involved DepEd personnel and campus journalists and coaches during the activity shall be chargeable against School/Division MOOE, PTA, SEF, local funds, or any other sources of funds subject to usual accounting and auditing rules and regulations.
9. The rest of the items and information stipulated in the *Division Memorandum* Division Memorandum No. 0048, s. 2025 and other related memoranda are retained.
10. Everyone is highly encouraged to continually support and recognize the value of equality and diversity of all personnel while complying with the directives set forth by this office.
11. Immediate dissemination of this Memorandum to all concerned is directed.
