Greetings of peace and prosperity!


The Department of Education (DepEd) recognizes the importance of community and stakeholders especially in promoting quality and relevant education. In line, Sta. Fe National High School maintains its relationship between the community and stakeholders by involving them in crafting plans and programs that will hone the students to become productive graduates, thereby ensuring a better future. One of significant suggestions of the community and stakeholders is opening additional Senior High School (SHS) Track, Technical-Vocational-Livelihood (TVL) to be particular, for the SH students.

Sta. Fe NHS has been offering SHS with General Academic Strand (GAS) since 2017. It has promoted good impact especially to the students in the timberland area who aspire to continue their education. As years go by, it has been identified that a solitary SHS Track does not suffice the need of all the students. In a consultation between the school and various stakeholders, it was made known that there are students who wants to acquire life skills such as but not limited to beauty care and dressmaking, which at the moment have high demand. Unfortunately, these students are left with no choice but to enrol in GAS and setting aside their educational goal rather than to enrol in other schools, which will incur additional expenses especially for transportation.

In addition, the faculty found out that 70-80% of the SH graduates have failed to continue higher education due to financial constraints. In effect, graduates opted to work to various firms and businesses that do not require educational alignment as long as they possess the fundamental skills needed in the successful completion of the required tasks. In order to curb the above-mentioned concerns, Sta. Fe NHS together with its various stakeholders adheres to open TVL Track. We firmly believe that by doing so, a more responsive, relevant, and quality education will be delivered to every student in the timberland area of New Corella District.

We believe that we share the common goal of producing competent, skilled, and productive graduates. We will be very hopeful in your approval in our humble request. Thank you and God bless!
