In relation to the conduct of the 2023 Davao Regional Athletic Association (DAVRAA) Meet to be held at Davao del Norte Sports and Tourism Complex (DNSTC) on April 24-28, 2023, this office hereby informs the field of the conduct of the in-house training of qualified athletes on April 8-23, 2023 at DNSTC.

It is advised that coaches, chaperones, qualified athletes, trainers, and other committees shall bring their personal sleeping paraphernalia and eating utensils to be used during the in-house training. Meanwhile, the athletes shall prepare parental consent signed by the parent.

Moreover, since there are trainings that fall on Saturdays and Sundays, service credits/compensatory overtime credits (COC) shall be given to the participants pursuant to DepEd Order No. 53,s. 2003.

Travel expenses of coaches and qualified athletes shall be charged against School MOOE subject to the usual accounting and auditing rules and regulations.

It is also advised that the required competencies supposedly taken during affected dates shall be compressed and to be taken ahead to patch-up the days for this activity or employ the blended learning mode.

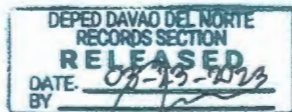
Everyone is enjoined to continually support and recognize the value of equality and diversity of all personnel while complying with the directives set forth by this office.
