The National Educators Academy of the Philippines (NEAP) in collaboration with the National Teachers College (NTC), has implemented **LUNDUYAN SA KAHUSAYAN** training program for Cohort 2 participants from July 4 to August 19, 2022, and Cohort 3 participants from November 14, 2022, to January 28, 2023.

Relative to the Lunduyan Implementation, there are still 315 PD participants tagged as Non-Completers for Cohort 2, and 180 non-completers for Cohort 3. Hence, NEAP and NTC will provide another opportunity for the tagged **Cohorts 2 and 3 for non-completers**. Those in the list are asked to join the upcoming **Cohort 4** of the **LUNDUYAN SA KAHUSAYAN**. Otherwise, the scholars need to refund in full to DepEd such sum of money as may have been defrayed by the Philippine government for expenses incidental to having attended the program or course, for failure to comply with any of the foregoing conditions.

1. The National Educators Academy of the Philippines (NEAP) in collaboration with the National Teachers College (NTC) has implemented Lunduyan sa Kahusayan training program for Cohort 2 participants from July 4 to August 19, 2022, and Cohort 3 participants from November 14, 2022 to January 28, 2023.
2. Relative to the Lunduyan implementation, there are still **315 PD participants tagged as non-completers for Cohort 2, and 180 non-completers for Cohort 3**. As stated in DM 82 s. 2020, and in the scholar's NEAP PDP contract, scholars are expected to *maintain the academic standards and other course requirements set for by the program. Otherwise, the scholars need to refund in full to DepEd such sum of money as may have been defrayed by the Philippine government for expenses incidental to having attended the program or course, for failure to comply with any of the foregoing conditions.*
3. NEAP and NTC will provide another opportunity for the tagged Cohorts 2 and 3 non-completer participants (see Enclosures 1 and 2) to complete their training courses. Those in the list are asked to join the upcoming Cohort 4 of Lunduyan sa Kahusayan. To ensure the privacy of the data, regional and division offices are requested to individually notify the concerned scholars.



4. The activity aims to:
  - a. provide chance to all the Cohorts 2 and 3 non-completers to finish their training program in Lunduyan sa Kahusayan; and
  - b. keep the non-completer PD participants away from the burden of refunding to DepEd the amount of the training program
5. The non-completers must email to NEAP - PDD - Delivery and Implementation Unit, through [pdd.pdi@deped.gov.ph](mailto:pdd.pdi@deped.gov.ph), their intention of completing the course **on or before April 21, 2023**. NTC will contact the interested participants through their registered email addresses regarding the details of the activity.
6. Additionally, should the need arise, this memorandum shall also cover all non-completers of upcoming Lunduyan cohorts. The list of non-completers shall be issued through an addendum to the enclosure of this memorandum.
7. Furthermore, we are again sharing the important links for the NEAP - PD programs batch 2, including the link for the completers and non-completers of Lunduyan (see Enclosure 3). To this date, there are still a good number of PD participants with no submission or incomplete submission of their documentary requirements. We request the assistance of the **regional focal persons** to upload in the google drive folder assigned to each region the submitted documents of the participants and update the tracker for the submitted documents **on or before May 26, 2023**.
