Subject: Designation of Permanent Representative and Alternate Representative

Greetings!

The Provincial Statistics Committee (PSC) as counterpart of the Regional Statistics Committees (RSCs) and the Philippine Statistics Authority (PSA) Board, serves as the policymaking body on statistical matters at the provincial level. Its regular meeting shall be held at least once a quarter of every year, same as of the frequency of meetings of the RSCs¹.

Considering that meetings serve as avenues to meet the goals of the PSC, as one of the Committees of the Provincial Development Council, the participation of its members are very necessary. Thus, the PSC Member can designate a permanent and alternate representative on meetings, who can make decisions, commitments, exercise same rights as of the members, and the right to vote².

Relatedly, the committee Chair is requesting that you will designate a staff as your permanent representative or alternate to represent you during the PSC meeting/s. Kindly issue a Special Order relating thereto to ensure that you will be well represented once the Committee convenes. Rest assure that a copy of the issued special order shall be furnished to the PSC Secretariat on or before 28 February 2021 for their reference and file.
