- 2. The Personnel In-Charge of personnel action shall provide secretariat services and maintain records of proceedings of the selection and deliberations. The Division Human Resource Merit Promotion and Selection Board (HRMPSB) shall have the following roles/functions and responsibilities:
- a. Evaluates and deliberates the qualifications of the applicants listed in the selection line up en banc;
- b. Makes a systematic assessment of the qualifications and competence of candidates for appointment to the vacant position;
- c. Conducts assessment such as; written examination, skill tests, interview of qualified candidates;
- d. Adopts the Equal Employment Opportunity Policy (EEOP) to all qualified applicants, including persons with disabilities (PWD), member of Indigenous communities and those with diverse sexual orientation, gender identity and expression (SOGIE) applicants.
- e. Submits the short list of qualified applicants to the appointing authority whose points are comparatively at pas with other based on the comparative assessment of the determined factors.
- 3. Any member who has a relative within the third degree by affinity or consanguinity with any of the applicants shall inhibit himself/herself.
