Pursuant to the approval of the recommendation for the progressive expansion by the President, Rodrigo Roa Duterte, on January 17, 2022, the Department of Education (DepEd) has issued Office Order (OO-OSEC-2022-003) titled "Interim Guidelines on the Expansion of Limited Face-toFace Classes", which provides guidance on the mechanisms and standards on the safe resumption of the face-to-face classes in basic education, pending issuance of the revised Joint Memorandum Circular (JMC) of DepEd and the Department of Health (DOH) on the operational guidelines on the implementation of limited face-to-face learning modality, as well as the DepEd Order (DO) on the guidelines of the implementation of the face-to-face classes.
- 2. In view thereof, all private and public schools are requested to submit every Tuesday the status of the school's progressive expansion phase of the limited face-to-face classes for monitoring and reporting purposes. Link is given below:
