In connection with the DepEd Memorandum No. DM-OUHROD-2023-1025, "Submission of Data of DepEd Employees on the Implementation of PhilHealth Konsulta" dated July 31, 2023, this Office recommends that the PhilHealth Konsulta registration process be facilitated by the Regional Office (for the RO employees) and to the Schools Division Offices (for the SDO employees and Schools teaching and non-teaching personnel). This is to expedite the registration and availment of PhilHealth Konsulta Benefits for all DepEd employees.

The ROs and SDOs shall directly coordinate and submit the PhilHealth registration form to its local PhilHealth office. Further, the teachers/employees may also opt to self-register through the PhilHealth Member portal (https://memberinquiry.philhealth.gov.ph/member). After the successful registration, the employees may already avail the Konsulta benefits, including the Annual Physical Examination.

How to Register to a **PhilHealth Konsulta Provider**



What is the PhilHealth Konsulta Package?

The Konsultasyong Sulit at Tama or the PhilHealth Konsulta Package is the expanded primary care benefit of PhilHealth.

Who can avail of the benefit?

All Filipinos shall be eligible to avail of the PhilHealth Konsulta benefit by registering to an accredited PhilHealth Konsulta Facility of their choice.

What does this benefit cover?

The PhilHealth Konsulta Package covers individual-based health services including initial and follow-up primary care consultations, health screening and assessment and access to selected diagnostic services, and medicines.

Services and medicines that can be availed from a PhilHealth Konsulta Provider:

- Philhealth Ko

 Consultation and case management for any conditions, including individual health education, that can be managed by a Primary Care Physician and team as determined by the legal scope of practice

 Provision of preventive health services Referral to specialty and higher levels of care.

How can you avail of the benefit?

To avail of the benefit, every Filipino shall be registered to a Konsulta primary care provider/facility of his/her choice.

How do you register to a PhilHealth Konsulta facility?

The member shall first update his/her Member Data Record (MDR), if necessary, by accomplishing the PhilHealth Member Registration Form (PMRF) and submitting it to the nearest PhilHealth Local Health Insurance Office (LHIO).

There are 2 ways to register:

- 1. Self-registration using the PhilHealth Member Portal
 - Log-in to the Member Portal or Member Online Registration through the official PhilHealth website: www.philhealth.gov.ph
 - Screenshot and/or print the confirmation message as proof that you have been already registered to the PhilHealth Konsulta Facility
- 2. Assisted registration through the following:
 - a. Current Employer
 - b. Social Worker of PhilHealth Konsulta Facility
 - c. Local Government Unit (LGU) / Office of Senior Citizen Affairs (OSCA)
 - d. PhilHealth Local Health Insurance Office (LHIO)
 - e. PhilHealth Customer Assistance Relations and Empowerment Staff (PCARES)
- f. PhilHealth Corporate Action Center (CAC)

To register, simply submit the duly accomplished Konsulta Registration Form to your preferred office, and receive the confirmation receipt with QR code or take a digital image through your phone camera.

Once registered, the member only needs to secure an Authorization Transaction Code (ATC) from PhilHealth and present it to his/her Konsulta Provider, to enjoy the benefit.
