In celebration of the Peace Treaty between the Philippines and Japan, the Department of Education, through the Bureau of Curriculum Development is conducting the 3<sup>rd</sup> **National Art Contest** with the theme *Dakilang Lahi*. The art contest aims to showcase the talents of Filipino learners in the **elementary level** in the arts, specifically in painting, reflecting the depth of their knowledge and understanding of the friendship between the Philippines and Japan.
