SCHOOL READINESS VALIDATION AND SIMULATION EXERCISES FOR LIMITED FACE-TO-FACE CLASSES IN PRIVATE SCHOOLS

To: Assistant Schools Division Superintendent Chief Education Program Supervisor, Curriculum Implementation Division (CID) Chief, Education Program Supervisor, School Governance and Operations Division (SGOD) Education Program Supervisors, Curriculum Implementation Division (CID) Public Schools District Supervisors Private School Administrators

- 1. The Department of Education (DepEd) issued a School Safety Assessment Tool (SSAT) which informs the schools of the required indicators and standards needed in preparation for the eventual reopening of classes while ensuring safety of learners and school personnel.
- 2. To ensure that the schools have met the required indicators and standards in the SSAT, the Division Validation Team shall conduct validation of data and simulation exercises on May 6,11, and 12, 2022. Attached are the updated list of schools and schedule of validation.
- 3. The validation team members shall be composed of the Division Composite Team for the Progressive Expansion of Limited Face-to-Face Classes together with personnel from Schools Governance and Operations Division, Education Program Supervisors, and Public Schools District Supervisors identified by their respective Division/ Section heads.
- 4. Further, it is reiterated that only school personnel are requested to join the validation and simulation exercises except for those who are immunocompromised and/or with active COVID-19 exposure.
- 5. Travel and other allowable expenses shall be charged to local funds subject to the usual accounting and auditing rules and regulation.
- 6. Health and safety protocols must be STRICTLY adhered and everyone is enjoined to continually support and recognize the value of equality and diversity in all activities relevant to this undertaking.
