1. Relative to the distribution of Quarter 4, SY 2021-2022 Self-Learning Modules (SLMs) which is spearheaded by the staff of the Division Supply Section with the assistance of the Learning Resource Management Section (LRMS), the field is hereby informed of the schedules and venues of the distribution of SLMs and Printing Materials which will be done by district as part of the stringent measures implemented by this office to fight the threats posed by COVID-19. 2. The next schedule of releasing the Quarter 4 SLMs will be communicated to the field through a separate Division Advisory.
3. The Public Schools District Supervisors (PSDS) or any representative of the PSDS, District LR Coordinators (Elementary and Secondary) and the District Supply Officer/ Property Custodian will receive the SLMs from the Division Supply Officer. Each district will also assign additional personnel who will assist in the retrieval and transport of the said SLMs to their respective districts.
4. In addition, the distribution of SLMs in the District level will be spearheaded by the Public Schools District Supervisors with the assistance of District Supply Officer/ Property Custodian, District LR Coordinators both elementary and secondary and other personnel within the district authorized by the PSDS. The official receiving personnel of the school such as the School Head, School Property Custodian and the School LR Coordinator will sign the Inventory Custodian Slip (ICS) and Requisition and Issue Slip (RIS) after the release of the said materials.
5. All personnel who are involved in the entire duration of distribution and retrieval of this materials are advised to strictly follow health protocols such as observing social distancing, and wearing of face mask.
6. All expenses relative to this activity such as the transportation and meal allowance shall be charged against local funds, subject to the usual government accounting and auditing rules and regulations.
