## REITERATION OF PARTICIPATION TO THE 2022 2ND QUARTER NATIONWIDE SIMULTANEOUS EARTHQUAKE DRILL (NSED)

- Pursuant to Regional Disaster Risk Reduction and Management Council (RDRRMC) Memorandum No. 16 s. 2022 "CY 2022 Quarterly Nationwide Simultaneous Earthquake Drill", all DepEd offices and schools are enjoined to participate in the quarterly conduct of earthquake drills. Hence, all students as well as teaching and non-teaching personnel are enjoined to participate in the conduct of the 2<sup>nd</sup> Quarter Nationwide Simultaneous Earthquake Drill on June 9, 2022, 9:00a.m.
- 2. It is also reiterated that in compliance to health and safety protocols, NSED exercises requiring physical interaction, particularly evacuation drills in DepEd offices and schools are hereby suspended. However, learners and personnel shall simultaneously practice the "duck, cover, and hold" procedure during the set NSED schedule.
- All other activities conducted in relation to the observance of NSED must adhere to health and safety
  protocols for COVID-19. Hence, provision of Information, Education, and Communication (IEC) campaign
  in NSED is also encouraged.
- 4. Proper documentation is also expected from offices and schools. Anent to this, all School Disaster Risk Reduction and Management (SDRRM) Coordinators are required to promptly submit the online NSED report through <a href="https://bit.lv/MindanaoSchools2Q">https://bit.lv/MindanaoSchools2Q</a>. In case of internet connectivity issues, SDRRM Coordinators may submit a hard copy of the Annex B. School Reporting Template enclosed in this memorandum. Also, pictures must be submitted at the DDN DAVNOR DRRM Facebook Group Page.
- 5. Everyone is enjoined to continually support and recognize the value of equality and diversity.
- 6. For wide dissemination and compliance.

REITERATION OF PARTICIPATION TO THE 2022 2nd QUARTER

NATIONWIDE SIMULTANEOUS EARTHQUAKE DRILL (NSED)

**ACTIVITIES** 

In relation to the approved National Disaster Risk Reduction and Management Council (NDRRMC) Memorandum No. 21, s. 2022 titled 'Conduct of the CY 2022 Quarterly Nationwide Simultaneous Earthquake Drill,' the Office of the Undersecretary for Administration (OUA), through the Disaster Risk Reduction and Management Service (DRRMS), enjoins schools and offices across all levels of the Department of Education (DepEd) to participate in the 2022 2nd Quarter Nationwide Simultaneous Earthquake Drill (NSED) on Thursday, June 09, 2022, 9:00 AM.

Due to the limitations in the conduct of mass gatherings and adherence to minimum public health standards, NSED exercises requiring physical interaction, particularly **evacuation drills in DepEd offices and schools, are hereby suspended.** However, all DepEd personnel and learners are enjoined to practice the "duck, cover, and hold" procedure simultaneously at the set time.

In order to further raise awareness regarding the earthquake drill, DRRM coordinators are encouraged to:

 intensify the Information, Education, and Communication (IEC) campaign by displaying earthquake preparedness measures at the offices and school bulletins or through online forums such as social media platforms and video conferences;

- 3. distribute maps containing evacuation routes and sites (at school or community) in coordination with LDRRMOs/BDRRMCs.

Proper documentation and post-activity evaluation are required. Therefore, all field offices are advised to make necessary preparations so that the required reports are submitted on time. Attached are the guidelines for the submission of the 2nd Quarter NSED Reports (Annex A).

#### Annex A

#### Guidelines on the Submission of the 2022 2nd Quarter Nationwide Simultaneous Earthquake Drill (NSED) Reports

All schools, schools division offices, and regional offices should thoroughly follow the guidelines below. Non-compliance is tantamount to the non-acceptance of said reports.

#### 2nd Quarter NSED Google Forms:

- 1. The School DRRM Coordinators shall fill out a google form link which is clustered into three (3), namely for schools in:
  - a. Luzon https://bit.ly/LuzonSchools2Q
  - b. Visayas https://bit.ly/VisayasSchools2Q
  - c. Mindanao https://bit.ly/MindanaoSchools2Q
- The Region and Division DRRM Coordinators shall also fill out a google form link specific for their respective offices:
  - a. Division https://bit.ly/Division2Q
  - b. Region https://bit.ly/Region2Q
- 3. The School, Division, and Region DRRM Coordinators shall accomplish the google form **not later than five (5) working days after quarterly NSED**.
- 4. In case schools are not able to access or fill out the Google Form due to internet connectivity issues, they may opt to use the attached reporting template (Annex B. School Reporting Template) and submit a copy through email to the respective Division DRRM Coordinator not later than ten (10) working days after the quarterly NSED.

#### Consolidation of Reports

- 1. The DRRMS will provide the regions and divisions daily updates of the NSED report submission after quarterly NSED.
- The DRRMS will provide the regions and divisions the final consolidated report ten (10) working days after quarterly NSED and shall be vetted by the Division DRRM coordinators.
- 3. The Division DRRM coordinators shall vet the final consolidated report. Should they find schools not included, kindly add and have the file be signed by the Schools Division Superintendent (SDS), and submit to respective Regional DRRM Coordinators copy furnish respective SDS not later than thirteen (13) working days after quarterly NSED.
- 4. The Regional DRRM coordinators must consolidate NSED reports from Division DRRM coordinators and send to the DRRMS via email drrmo+dp@deped.gov.ph copy furnish respective Regional Directors not later than sixteen (16) working days, after quarterly NSED.
- The official number of schools that participated in NSED will be based on the final consolidated NSED report signed by the Regional Director or authorized official from the regional office to be submitted to DRRMS.
