Herewith is the OUA-IN-090122-005 or the Reiteration of Participation to the 2022 3rd Quarter Nationwide Simultaneous Earthquake Drill (NSED) on September 8, 2022 at 9:00 a.m.

With this, all personnel and learners are enjoined to practice the "duck, cover, and hold on" procedure. However, other activities relevant to this undertaking, including evacuation activities, shall be within the discretion of the heads of offices and schools depending on its suitability in adherence to the minimum health and safety protocols and in due consideration to the respective vulnerability to COVID-19.

Further, intensifying of Information, Education, and Communication (IEC) campaign on earthquake preparedness, discussing results of the Family Earthquake Preparedness Homework with the PTA and Barangay officials, and distribution of evacuation maps in coordination with the Local DRRM Office are encouraged.

Proper documentation is also expected from offices and schools. Anent to this, all School Disaster Risk Reduction and Management (SDRRM) Coordinators are required to promptly submit the NSED reports. Please see the attached Annex A or the Guidelines on the Submission of the 2022 3rd Quarter Nationwide Simultaneous Earthquake Drill (NSED) Reports and Annex B or the School-Level Report on the 3rd Quarter Nationwide Simultaneous Earthquake Drill (NSED) for reference and guidance.

REITERATION OF PARTICIPATION TO THE 2022 3RD

QUARTER NATIONWIDE SIMULTANEOUS EARTHQUAKE DRILL

(NSED)

In relation to the National Disaster Risk Reduction and Management Council (NDRRMC) Memorandum No. 132, s. 2022, dated 31 August 2022, entitled 'Participation to the Third Quarter Nationwide Simultaneous Earthquake Drill 2022,' the Office of the Undersecretary for Administration (OUA), through the Disaster Risk Reduction and Management Service (DRRMS), enjoins schools and offices across all levels of the Department of Education (DepEd) to participate in the 2022 3rd Quarter Nationwide Simultaneous Earthquake Drill (NSED) on September 08, 2022, Thursday at 9:00 a.m.

Further, in light of the recent Magnitude 7.0 Earthquake in Abra as well as the series of ground shaking in other parts of the country, all DepEd personnel and learners are enjoined to practice the "duck, cover, and hold" procedure as a minimum requirement.

The conduct of in-person or online drill, including the evacuation activities, shall be within the discretion of the heads of offices and schools as they see it safe and suitable to their area in due consideration to their respective vulnerability to COVID-19 pandemic and minimum public health standards

In order to further raise awareness regarding earthquake preparedness, DRRM coordinators are encouraged to:

 intensify the Information, Education, and Communication (IEC) campaign by displaying earthquake preparedness measures at the offices and school bulletins or through online forums such as social media platforms and video conferences;

- discuss results of Family Earthquake Preparedness¹¹ Homework to the PTA and barangay officials for consideration in the school and community preparedness planning, as mandated in DO No. 27, s. 2015; and
- distribute maps containing evacuation routes and sites (at school or community) in coordination with LDRRMOs/BDRRMCs.

For more information, kindly refer to Enclosure No. 1^[2] (DepEd Order No.48 s. 2012). Additional preparedness and response measures are listed in Enclosure 2^[3] (DepEd Order No. 33, s. 2021).

Proper documentation and post-activity evaluation are required. Therefore, all DepEd offices and schools are advised to make necessary preparations so that the required reports are submitted on time. Attached are the guidelines for the submission of the 3rd Quarter NSED Reports (Annex A).

Annex A

Guidelines on the Submission of the 2022 3rd Quarter Nationwide Simultaneous Earthquake Drill (NSED) Reports

All schools, schools division and regional offices, as well as the Central Office should thoroughly follow the guidelines below. Non-compliance is tantamount to the non-acceptance of said reports.

3rd Quarter NSED Google Forms:

- The DepEd Central Office shall fill out the google link for the bureaus, services, and offices: https://bit.ly/Central3Q
- 2. The School DRRM Coordinators shall fill out a google form link which is clustered into three (3), namely for schools in:
 - a. Luzon https://bit.ly/LuzonSchools3Q
 - b. Visayas https://bit.ly/VisayasSchools3Q
 - c. Mindanao https://bit.ly/MindanaoSchools3Q
- The Region and Division DRRM Coordinators shall also fill out a google form link specific for their respective offices:
 - a. Division https://bit.ly/Division3Q
 - b. Region https://bit.ly/Region3Q
- 4. The School, Division, and Region DRRM Coordinators shall accomplish the google form not later than five (5) working days after quarterly NSED.
- 5. In case that schools are not able to access or fill out the Google Form due to internet connectivity issues, they may opt to use the attached reporting template (Annex B. School Reporting Template) and submit a copy through email to the respective Division DRRM Coordinator not later than ten (10) working days after the quarterly NSED.

Consolidation of Reports

- The DRRMS will provide the regions and divisions daily updates of the NSED report submission after quarterly NSED.
- The DRRMS will provide the regions and divisions the final consolidated report ten
 (10) working days after quarterly NSED and shall be vetted by the Division DRRM
 coordinators.
- The Division DRRM coordinators shall vet the final consolidated report. Should they
 find schools not included, kindly add and have the file be signed by the Schools
 Division Superintendent (SDS), and submit to respective Regional DRRM
 Coordinators copy furnish respective SDS not later than thirteen (13) working days
 after quarterly NSED.
- The Regional DRRM coordinators must consolidate NSED reports from Division DRRM coordinators and send to the DRRMS via email drrmo@deped.gov.ph copy furnish respective Regional Directors not later than sixteen (16) working days, after quarterly NSED.
- The official number of schools that participated in NSED will be based on the final consolidated NSED report signed by the Regional Director or authorized official from the regional office to be submitted to DRRMS.
