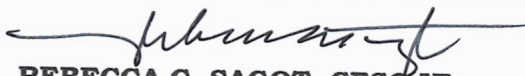

Subject: REITERATION OF THE NO COLLECTION POLICY, USE OF GOVERNMENT FACILITY AND CONDUCT OF TUTORIAL SERVICES WITHOUT THE APPROVAL OF THE SCHOOLS DIVISION SUPERINTENDENT

Date : November 7, 2022

Pursuant to DepEd Order 19 s. 2008 "Implementation of No Collection Policy in All Public Elementary and Secondary Schools" this Office reiterates the no collection of any amount for tutorial purposes. More so, DepEd Order No.143, s. 2016 "Reiteration of the No Collection Policy from the Parents-Teachers Association" explicitly restates the following policies:

1. no fees shall be collected from school children in Kindergarten up to Grade anytime during the School Year (SY);
2. no collection of fees shall be made for Grade 5 to High School learners from June to July;
3. starting August until the end of the SY, the following membership fees and contributions may be collected on a voluntary basis:

4. The aforementioned DepEd issuances (DMS and DOS), together with the references cited for the voluntary school contributions, reiterate that payment of these fees are voluntary in nature, payments not on the abovementioned list are strictly not allowed; and
5. further, in DO 41, s. 2012, it is stressed that in no case shall non-payment of voluntary school contributions or membership fees shall be made as a basis for admission, non-promotion, or non-issuance of clearance to a student by the school concerned.

Further, the use of government facilities/schools for tutorial purposes of a private entity or institution is strongly discouraged without the approval of the Schools Division Superintendent (SDS).
