Subject: **REGIONAL TRAINING FOR FILIPINO SIGN LANGUAGE**

Date: August 8, 2022

1. In line with the thrust of the Department of Education in ensuring the Basic Education Learning Continuity Plan, this Office through the Curriculum Implementation Division (CLMD) shall conduct the Regional Training for Filipino Sign Language (FSL) on August 10-12, 2022 at Ritz Hotel, Porras Street, Davao City.
2. The objective of the regional training are as follows:
  - a. capacitate SPED and receiving teachers on the use of Filipino Sign Language;
  - b. implement initiatives that will ensure the continuity of learning of learners with disabilities through quality, relevant and appropriate learning that are accessible in any format; and
  - c. embrace the use of Filipino Sign Language in public schools.
