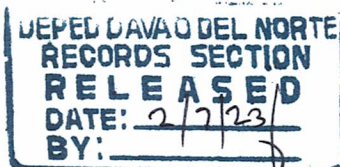

5. Immediate dissemination of this memorandum to all concerns is desired.

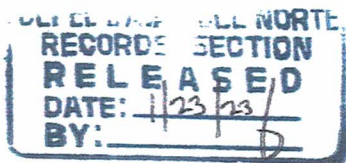
