GUIDELINES ON THE PROPER UTILIZATION OF DELIVERED SELF-LEARNING MODULES

- Relative to DepEd Order No. 18, s. 2020 which provides guidelines for the release and utilization of funds for the provision of learning resources in light with the implementation of Basic Education Learning Continuity Plan (BE-LCP), this office reiterates that all Self-Learning Modules (SLMs) procured either by Central Office (CO), Regional Office (RO), and the School Division Office (SDO) shall be used and be reused for the current school year and the subsequent school years.
- 2. During the monitoring, several SLMs have been found in some schools that are improperly managed and stored accordingly due to lack of conducive storage rooms.
- 3. To address this problem, this division instructs all schools to employ this methodology for the proper utilization, storage, and maintenance of SLMs:
 - a. SLMs shall be distributed to the learners either quarterly, monthly, weekly, or depending on the school's plan.
 - b. The distributed SLMs shall be properly accounted like books. Advisers and subject teachers shall be required to have records of the distributed SLMs.
 - c. SLMs shall be returned and collected at the end of every quarter and or depending on the school's strategy in collecting the said SLMs.
- 4. The distributed SLMs shall be used for enrichment and other home-based learning activities of the learners in case of calamity where we don't anymore cancel classes, but instead we automatically shift to modular/blended learning.
- 5. The implementation of this specific scheme is expected to be strictly monitored by the school heads. Teachers are also expected to be creative in finding ways on how to utilize the SLMs in its full extent for a more effective and uninterrupted teaching-learning process.
