Due to conflict of schedules, the Bi-Monthly meeting will be moved to **March 3, 2023**. All other details in the previous memorandum would still in effect.

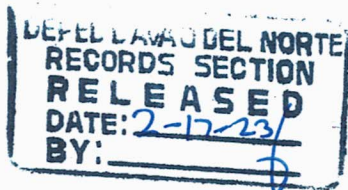

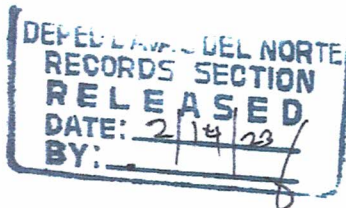
