- 1. Relative to Presidential Proclamation No. 439, s. 2003 declaring May of every year as the National Heritage, and Regional Memorandum CLMD-2023-150 entitled 2023 National Heritage Month Celebration, this Office supports the conduct of the Division Poster making Contest on **May 16, 2023, at Tuganay Elementary School**. The celebration centers on the commemoration of the Battle of Ising, at the Municipality of Carmen. The guidelines and mechanics are attached to this Memorandum.
- 2. The event is a preliminary activity of the commemoration of the Battle of Ising, which shall be held on May 31, 2023, at the Battle of Ising Shrine, Carmen, Davao del Norte. From among the entries, **TOP 10** shall be declared on **May 16, 2023**. The **Final Announcement of Winners** shall be on May 31, 2023, during the commemoration proper.
- 3. All entries shall be displayed on May 31, 2023, with poster stands to prop up their poster for the art exhibit during the Commemoration of the Battle of Ising. This shall be prepared by the schools involved.
- 4. During the event, the coach shall submit endorsement of the entry from the school head, and parent consent for the participation of the students.
- 5. From the Top 10, the Top 5 winners shall receive Certificate of Recognition and Cash Prizes, while the other 5 shall also have their consolation prizes.
- 6. Attached also in this Memorandum is the list of Committees.

# Poster Making Guidelines & Mechanics

- 1. Participants must be a public junior high school student of the Division of Davao del Norte.
- 2. Only one student-participant per public secondary school is allowed.
- 3. Participants shall work on their posters at their own pace and must submit a finished poster.
- 4. Participants must also submit a poster stand to prop up their poster for the art exhibit during the Commemoration of the Battle of Ising.
- 5. The competition shall be held on May 16, 2023, at Tuganay Elementary School Carmen District, to start at exactly 8:00am.
- 6. The poster must fully respond to the theme of the event: BATTLE OF ISING: Pamana ng Kabayanihan at Kagitingan
- 7. Participants may seek assistance from a coach, but coaches are only allowed to provide guidance and cannot directly participate in the creation of the poster.
- 8. The contestants are given **4 hours** to finish their outputs. No time extension for the late participants.
- 9. Participants shall use 1 whole size illustration board and must use the white side in vertical orientation.
- 10. The medium for visual artistry shall only be limited to oil pastel and shall be provided by the contestant/ school.
- 11. The finished output should not contain label or name that may identify the school. No other identifying marks will be allowed to appear in the artworks.
- 12. The poster must be original. If the submitted poster is found to have been plagiarized, it will be disqualified from the competition.
- 13. From among the entries, the **TOP 10** shall be selected, however, the **WINNERS** shall be announced during the commemoration schedule of the Battle of Ising.
- 14. The contestants and coaches of the Top 10 winning posters will receive a Certificate of Recognition. The TOP 3 winners shall also receive cash prizes.
- 15. The winners will be announced during the Commemoration of the Battle of Ising.
- 16. All entries shall be considered property of DepEd Davao del Norte and may be used by the Division for publication and any other legal purpose.
- 17. Upon joining the contest, student contestants who are over 18 years of age, or their parents, guardians, or caregivers, if they are minors, consent to the use of their personal information as included in the outputs that they will submit for purposes of publication if they are declared as winners, consistent with the provision of the Data Privacy Act.
- 18. DepEd shall not be liable for any infringement of any intellectual property rights arising from the use of the entries. In case there are third-party claims of such infringement of any intellectual property rights, the contestants hold DepEd free and harmless against such claims.

- 19. Non-compliance with any of the stated contest rules and mechanics is a ground for disqualification.
- 20. The decision of the board of judges is final and irrevocable.

# CRITERIA

The criteria for judging will be as follows:

(The color, lines, shapes, and other artistic elements should	2070
