4. Everyone is highly encouraged to continually support and recognize the value of equality and diversity of all personnel and strict observance of health protocols while complying with the directives set forth by this office.




5. Transportation and other incidental expenses of the participants shall be charged against local fund subject to the existing accounting and auditing rules and regulations.
