LAUNCH AND ORIENTATION OF JOURNALISM

- 2. Pursuant to the Republic Act No. 7079, it declares the policy of the State to uphold and protect the freedom of the press even at the campus level and to promote the development and growth of campus journalism as a means of strengthening ethical values, encouraging critical and creative thinking, and developing moral character and personal discipline of the Filipino youth.
- 3. In regard to the Launch and Orientation of Journalism effective on May 19, 2023, at 8:00 a.m. at the Department of Agriculture Function Hall, Maniki, Kapalong, Davao del Norte. This activity aims to:
 - a. Capacitates in the format and techniques of Journalism.
 - b. Enhancing writing's ethical principles.
 - c. Facilitating creative thinking.
 - d. Foster the love of writing.
- 4. All Elementary and Secondary School Paper Advisers and School Heads are encouraged to actively participate in this training to sharpen their abilities and eventually translate their learning to all learners.
- 5. **NO DISRUPTION** of classes shall be imposed in the conduct of the training hence all the Elementary and Secondary School Paper Advisers will shift to Blended Learning Modality and employ all the possible means to deliver and access quality education pursuant to DepEd Order No. 9, s. 2005 titled Instituting Measures to Increase Engaged Time-On-Task and Ensuring Compliance Therewith.
- 6. Furthermore, the Implementation of Blended Learning Modality in Public Elementary and Secondary Schools in Langilan District shall be monitored by the Public Schools District Supervisor who shall make any necessary adjustments to ensure that all learners are receiving high-quality education.
- 7. All parties concerned are required to strictly observe the health protocols as prescribed by the Inter-Agency Task Force (IATF) on COVID-19 during this
